Given the ongoing effects of the COVID Pandemic, stakeholder engagement has been a critical component of our school and plan for learning opportunities over the last 18 months. To inform this plan, we have used the input of our stakeholder groups to design learning opportunities that will address learning loss and ensure learning continuity and progression for learners during the 2021-22 and 2022-23. Matrix for Success has conducted online stakeholder surveys at various points since reopening in order to gauge the state of our families. These surveys have provided all teachers, staff and families an opportunity to provide feedback on school plans and decisions made for the 2021-22 school year, as well as to elicit input on the needs of the instructional program. School site administration reached out to stakeholders gather input about school development, instructional decisions, budgetary decisions, learning loss mitigation funds, student support, and other needs facing our community. Teachers and staff meet regularly during weekly professional development meetings. Specific focus work groups were held in to further discuss plans for meeting the mental health needs of students. Feedback from teachers and staff allowed for input on the school program, goals, and implementation of various assessments and learning models (Renaissance STAR, Collective Care Continuum, etc.). Student feedback on learning loss

mitigation strategies were gathered through outreach emails and phone calls, as well as in-person meetings with counseling and teaching staff. All stakeholders were offered the opportunity to communicate directly with site administration, as well as through our Wellness Teams phone contacts, to provide additional feedback on models and strategies to best meet the needs of our school community.

Matrix, as a non-classroom-based school, listened to input from our stakeholders, indicating a need for more virtual options for learning, as many of our families are not comfortable with or able to make a full return to in-person learning. Teachers, counseling staff, and support personnel have all adjusted their schedules to accommodate both in-person learning and appointments, as well as virtual learning and meetings. Support outside of regular school hours has been adopted by many teachers, and Matrix has expanded their offering of virtual enrollment appointments and electronic document review and signing. Teacher, parent, and student groups also expressed a desire to invest in technology support to ensure that all students have the necessary resources to access online content (computer laptops and internet connectivity). Teachers and staff indicated access to supplement digital platforms (Zoom, Pear Deck, Canva, DocuSign, Adobe Creative Cloud, etc.) to enhance student engagement, as well as additional training on our diploma plus platform (DPNG).
