III. PazLo Education Foundation – School Status and Renewal Update

- A. APEX Academy
 - a. Where we are, AB 1505, Plan, COVID19
 - i. APEX, Diploma Plus, C3

Director Paz and Lopez shared with the governing Board discussions held with LAUSD's CSD staff on the renewal of APEX Academy in the context of the authorizer's implementation of AB 1505. The Governing Board was informed of APEX's placement on the "Low Band" within the AB 1505; this placement recommends non-renewal based on standardized testing from 2018-19 (a questionable placement, as no testing is available on 19-20, 20-21) and provides a "best case" scenario of a 2-year renewal assuming LAUSD recommends (???). Updates on COVID19 and implementation of DP and C3 were provided. Discussion was held regarding alternatives to ensure all families at APEX are taken care during the 2021-22 school year.

- B. Matrix for Success Academy
 - a. Where we are, AB 1505, Plan, COVID19
 - i. Matrix, Diploma Plus, C3

Director Paz Lopez shared with the governing Board discussions held with LAUSD's CSD staff on the oversight of Matrix for Success Academy in the context of the authorizer's implementation of AB 1505. The Governing Board was informed that as a DASS school, Matrix's placement is on the "Middle Band" within the AB 1505; this placement is more favorable for a full renewal and considers internal verified data sources as prescribed by the CA Board of Education. A full 5-year renewal is possible assuming LAUSD recommends it. Updates on COVID19 and implementation of DP and C3 were provided. Discussion was held regarding the plans to significantly expand enrollment during the 2021-22 school year.

- C. PazLo IP Resolution update and review From September 2020
 - a. Options

Director Paz and Lopez shared with the Governing Board available opportunities to share our education innovation with schools in the greater Los Angeles Area. An update was provided regarding the organization of the instructional model, Diploma Plus, and the mental health innovation model Collective Care Continuum. Director Paz shared about his taking

the lead on innovation sharing, while Director Lopez shared about taking the lead on internal capacity and leadership development within the schools. Board Member Mattenson and Wagle asked about specific individuals being developed. Director Lopez shared that key people within each school has full understanding of both the instructional and mental health models for sustainability, however more people will be coached and trained over the next several months as we plan the implementation of the C3 platform at both schools. Consultations with legal counsel have been held in preparation to protect intellectual property involving the DP-DPNG instructional model and the C3 mental health model.

Board members shared and discussed items regarding internal capacity and leadership development. Board Member Mattenson and Wagle asked about specific individuals being developed.
